



This column is calculated as the ratio of number of loans modified over the total number of loans in the trust.

The 8.8% loans modified shown on page 2 is the ratio of number of loans modified for the first two categories over the total number of loans in the trusts. That is,  $(60,626+74,321) / (299,523+1,226,379) = 8.8\%$ .

Aside from original collateral balance, all the figures in the table are as of November 2012.

**VARIANT 1:**

For a loan to be modified: (i) the loan is repurchased; and (ii) aggregate principal balance remain below 5% (usually Section 3.12(a)). 49 trusts, \$12.5 billion in modified loans.

**PSA**

The Master Servicer may agree to a modification of any Mortgage Loan (the "Modified Mortgage Loan") if **(i) CHL purchases the Modified Mortgage Loan** from the Trust Fund immediately following the modification as described below and (ii) the Stated Principal Balance of such Mortgage Loan, when taken together with the aggregate of the Stated Principal Balances of all other Mortgage Loans in the same Loan Group that have been so modified since the Closing Date at the time of those modifications, does not exceed an amount equal to 5% of the aggregate Certificate Principal Balance of the related Certificates. Effective immediately after the modification, and, in any event, on the same Business Day on which the modification occurs, all interest of the Trustee in the Modified Mortgage Loan shall automatically be deemed transferred and assigned to CHL and all benefits and burdens of ownership thereof, including the right to accrued interest, shall pass on to CHL.

**PROSPECTUS SUPPLEMENT**

Countrywide Home Loans will be permitted under the Pooling and Servicing Agreement to solicit borrowers for reductions to the Mortgage Rates of their respective Mortgage Loans. If a borrower requests such a reduction, the Master Servicer will be permitted to agree to the rate reduction provided that (i) **Countrywide Home Loans purchases the Mortgage Loan from the Trust Fund immediately following the modification** and (ii) the Stated Principal Balance of such Mortgage Loan, when taken together with the aggregate of the Stated Principal Balances of all other Mortgage Loans in the same Loan Group that have been so modified since the Closing Date at the time of those modifications, does not exceed an amount equal to 5% of the aggregate initial Certificate Principal Balance of the related Certificates. Countrywide Home Loans will remit the Purchase Price to the Master Servicer for deposit into the Certificate Account within one Business Day of the purchase of that Mortgage Loan. Purchases of Mortgage Loans may occur when prevailing interest rates are below the Mortgage Rates on the Mortgage Loans and borrowers request modifications as an alternative to refinancings. Countrywide Home Loans will indemnify the Trust Fund against liability for any prohibited transactions taxes and related interest, additions or penalties incurred by any REMIC as a result of any modification or purchase.

**VARIANT 2:**

For a loan to be modified: (i) the modification is in lieu of refinancing; and (ii) at the approximate market rate; and (iii) Countrywide purchases the loan from the Trust Fund (usually Section 3.11(b)). 391 trusts, \$18.9 billion in modified loans.

**PSA**

**PROSPECTUS SUPPLEMENT**

Countrywide may agree to a modification of any Mortgage Loan (the "Modified Mortgage Loan") if (i) the modification is in lieu of a refinancing and (ii) the Mortgage Rate on the Modified Mortgage Loan is approximately a prevailing market rate for newly-originated mortgage loans having similar terms and **(iii) Countrywide purchases the Modified Mortgage Loan from the Trust Fund** as described below. Effective immediately after the modification, and, in any event, on the same Business Day on which the modification occurs, all interest of the Trustee in the Modified Mortgage Loan shall automatically be deemed transferred and assigned to Countrywide and all benefits and burdens of ownership thereof, including the right to accrued interest thereon from the date of modification and the risk of default thereon, shall pass to Countrywide. The Master Servicer shall promptly deliver to the Trustee a certification of a Servicing Officer to the effect that all requirements of this paragraph have been satisfied with respect to the Modified Mortgage Loan. For federal income tax purposes, the Trustee shall account for such purchase as a prepayment in full of the Modified Mortgage Loan.

- (a) **The master servicer may modify any Mortgage Loan provided that the master servicer purchases the Mortgage Loan from the trust fund immediately following the modification.** No modification of a Mortgage Loan may be made unless the modification includes a change in the interest rate on the related Mortgage Loan to approximately a prevailing market rate. Any purchase of a Mortgage Loan subject to a modification will be for a price equal to 100% of the Stated Principal Balance of that Mortgage Loan, plus accrued and unpaid interest on the Mortgage Loan up to the next Due Date at the applicable net mortgage rate, net of any unreimbursed advances of principal and interest on the Mortgage Loan made by the master servicer. The master servicer will deposit the purchase price in the Certificate Account within one business day of the purchase of that Mortgage Loan. Purchases of Mortgage Loans may occur when prevailing interest rates are below the interest rates on the Mortgage Loans and mortgagors request modifications as an alternative to refinancings. The master servicer will indemnify the trust fund against liability for any prohibited transactions taxes and any related interest, additions or penalties imposed on the REMIC as a result of any modification or purchase.
- (b) Countrywide Home Loans will be permitted under the pooling and servicing agreement to solicit borrowers for reductions to the Mortgage Rates of their respective Mortgage Loans. **If a borrower requests such a reduction, the master servicer will be permitted to agree to the rate reduction provided that Countrywide Home Loans purchases the Mortgage Loan from the issuing entity immediately following the modification.** Any purchase of a Mortgage Loan subject to a modification will be for a price equal to 100% of the Stated Principal Balance of that Mortgage Loan, plus accrued and unpaid interest on the Mortgage Loan up to the next Due Date at the applicable Net Mortgage Rate, net of any unreimbursed advances of principal and interest on the Mortgage Loan made by the master servicer. Countrywide Home Loans will remit the purchase price to the master servicer for deposit into the Certificate Account within one business day of the purchase of that Mortgage Loan. Purchases of Mortgage Loans may occur when prevailing interest rates are below the interest rates on the Mortgage Loans and mortgagors request modifications as an alternative to refinancings. Countrywide Home Loans will indemnify the issuing entity against liability for any prohibited transactions taxes and related interest, additions or penalties incurred by any REMIC as a result of any modification or purchase.

**VARIANT 3:**

For a loan to be modified: (i) no default exists; and (ii) Countrywide repurchases the loan (usually Section 3.11(b)). 6 trusts, \$0.5 billion in modified loans.

**PSA**

Countrywide is permitted to solicit Mortgagors for reductions to the Mortgage Rates of their respective Mortgage Loans so long as the Mortgagors are not selected for solicitation based on the inclusion of the related Mortgage Loans in the Trust Fund. If a Mortgagor requests a reduction to the Mortgage Rate for the related Mortgage Loan, the Master Servicer shall agree to a reduction in the Mortgage Rate of that Mortgage Loan (the "Modified Mortgage Loan") if (i) no monetary default exists with respect to such Mortgage Loan and **(ii) Countrywide, in its corporate capacity, agrees to purchase the Modified Mortgage Loan from the Trust Fund immediately following the modification as described below.** Effective immediately after the modification, and, in any event, on the same Business Day on which the modification occurs, all interest of the Trustee in the Modified Mortgage Loan shall automatically be deemed transferred and assigned to Countrywide and all benefits and burdens of ownership thereof, including the right to accrued interest thereon from the date of modification and the risk of default thereon, shall pass to Countrywide. The Master Servicer shall promptly deliver to the Trustee a certification of a Servicing Officer to the effect that all requirements of this paragraph have been satisfied with respect to the Modified Mortgage Loan. For federal income tax purposes, the Trustee shall account for such purchase as a prepayment in full of the Modified Mortgage Loan.

**PROSPECTUS SUPPLEMENT**

Countrywide Home Loans is permitted under the pooling and servicing agreement to solicit borrowers for reductions to the mortgage rates of their respective mortgage loans. If a borrower requests a reduction to the mortgage rate for the related mortgage loan, the master servicer is required to agree to that reduction if Countrywide Home Loans, in its corporate capacity, **agrees to purchase that mortgage loan** from the issuing entity.

**VARIANT 4:**

For the interest rate on a loan to be reduced: (i) no default exists, (ii) CHL purchases the loan; and (iii) principal balance requirement is met (usually Section 3.12(a)). 2 trusts, \$0.5 billion in modified loans.

**PSA**

CHL is permitted to solicit Mortgagors for reductions to the Mortgage Rates of their respective Mortgage Loans so long as the Mortgagors are not selected for solicitation based on the inclusion of the related Mortgage Loans in the Trust Fund. If a Mortgagor requests a reduction to the Mortgage Rate for the related Mortgage Loan, the Master Servicer shall agree to a reduction in the Mortgage Rate of that Mortgage Loan (the "Modified Mortgage Loan") if (i) no monetary default exists with respect to such Mortgage Loan, (ii) **CHL, in its corporate capacity, agrees to purchase the Modified Mortgage Loan from the Trust Fund immediately following the modification as described below** and (iii) the Stated Principal Balance of such Mortgage Loan, when taken together with the aggregate of the Stated Principal Balances of all other Mortgage Loans that have been so modified since the Closing Date at the time of those modifications, **does not exceed an amount equal to 5% of the aggregate initial Certificate Principal Balance of the Certificates.**

**PROSPECTUS SUPPLEMENT**

Countrywide Home Loans is permitted under the Pooling and Servicing Agreement to solicit borrowers for reductions to the Mortgage Rates of their respective Mortgage Loans. If a borrower requests a reduction to the Mortgage Rate for the related Mortgage Loan, the Master Servicer is required to agree to that reduction if (i) Countrywide Home Loans, in its corporate capacity, **agrees to purchase that Mortgage Loan** from the issuing entity and (ii) the Stated Principal Balance of such Mortgage Loan, when taken together with the aggregate of the Stated Principal Balances of all other Mortgage Loans in the same Loan Group that have been so modified since the Closing Date at the time of those modifications, does not exceed an amount equal to 5% of the aggregate initial Certificate Principal Balance of the related Certificates.

**VARIANT 5:**

For a loan to be modified: (i) the borrower requests rate reduction; and (ii) the servicer purchase the loan from the trust (usually Section 3.01(e)). 2 trusts, \$0 billion in modified loans (not a single loan was modified).

**SSA**

Furthermore, the Sponsor, without prior approval from the Rating Agencies, may solicit mortgagors for a reduction in Loan Rates. The Loan Rates of Mortgage Loans having Asset Balances at the time of the proposed modification that aggregate over time not more than 5.0% of the Original Note Principal Balance may be subject to reduction. If a mortgagor notifies the Sponsor or the Master Servicer that it wants a reduction in Loan Rate, **the Sponsor shall purchase the Mortgage Loan from the Trust** as described below. Effective immediately on the same Business Day on which the Sponsor delivers the Purchase Price for the relevant Mortgage Loan to the Master Servicer, all interest of the Trust in the relevant Mortgage Loan shall automatically be transferred and assigned to the Sponsor and all benefits and burdens of ownership of the relevant Mortgage Loan, including the right to accrued interest on it from the date of purchase and the risk of default on the Mortgage Loan, shall pass to the Sponsor.

**PROSPECTUS SUPPLEMENT**

The sponsor also will be **obligated to purchase any mortgage loans** with respect to which it has agreed to reduce the loan rate and, in certain circumstances, it has agreed to increase the credit limit, subject to certain limitations.

**VARIANT 6:**

No repurchase obligation (usually in section 3.12 of the PSA and the servicing section of the Prospectus). Not provided in Covered Trusts before April, 2007. 54 trusts, \$5.1 billion in modified loans.

**PSA**

Nothing in this Section 3.12(a) restricts the ability of the Master Servicer to modify a Mortgage Loan in a manner that is consistent with the servicing standard set forth in Section 3.01; provided, however, that **CHL shall have no obligation to purchase any such modified Mortgage Loan.**

**PROSPECTUS SUPPLEMENT**

In addition, the master servicer may agree to modifications of a Mortgage Loan, including reductions in the related Mortgage Rate, if, among other things, it would be consistent with the customary and usual standards of practice of prudent mortgage loan servicers. Such modifications may occur in connection with workouts involving delinquent mortgage loans. **Countrywide Home Loans is not obligated to purchase any such modified Mortgage Loans.**

**VARIANT 7:**

No specific re-purchase requirement in PSAs (although some Prospectus Supplements reveal otherwise). We conservatively interpret this as no re-purchase obligation. 26 trusts, \$.6 billion in modified loans.
