I, John G. Moon, hereby affirm under the penalty of perjury that the following is true and correct:

- 1. I am an attorney in good standing of the bar of this Court and of Miller & Wrubel P.C., counsel to Respondents Triaxx Prime CDO 2006-1, Ltd., Triaxx Prime CDO 2006-2, Ltd., and Triaxx Prime CDO 2007-1 (together, "Triaxx"). I submit this affirmation in support of Triaxx's Motion for Judgment During Trial in the above-captioned Article 77 proceeding.
