- 1. I am a member in good standing of the bar of this Court. I am a partner with the law firm Wollmuth Maher & Deutsch LLP, counsel to The Western and Southern Life Insurance Company, Western-Southern Life Assurance Company, Columbus Life Insurance Company, Integrity Life Insurance Company, National Integrity Life Insurance Company, and Fort Washington Investment Advisors, Inc. (collectively, "Western & Southern"). I am familiar with the matters set forth in this Affirmation, either from personal knowledge or from my review of the files in this matter. I offer this Affirmation in support of Western & Southern's petition to intervene in this proceeding.

- 2. The Bank of New York Mellon ("BNYM") commenced this proceeding by filing a petition under CPLR 7701 on June 29, 2011. BNYM is seeking judicial approval of a proposed settlement with this Court that it entered into as trustee on behalf of trusts corresponding to 530 residential mortgage-backed securitizations.
- 3.
